RE: *Concealed Carry License Reciprocity with Idaho*


Dear Ms. Altig:

On behalf of the Attorney General Bob Ferguson, thank you for your inquiry regarding concealed carry reciprocity with Idaho received July 10, 2015.

Washington's reciprocity statute (RCW 9.41.073), allows us to recognize other states' concealed pistol/handgun licenses when their statutes meet the following conditions:

- 1) Recognizes and gives effect in that state to a concealed pistol license issued under the laws of the state of Washington; and
- 2) Does not issue concealed pistol licenses to persons under twenty-one years of age; and
- 3) Mandatory fingerprint-based background checks for criminal history; and
- 4) Mandatory mental health history check.

Idaho issues an original and an enhanced Concealed Weapons License. This letter confirms that Washington will continue to have reciprocity with Idaho's Enhanced Concealed Weapons License only. Thank you for your continued courtesies.
